## 国際パネルディスカッション: INORMS 2020 Hiroshimaへ向けて

今年度の国際専門委員会セッションでは、本セッションを含め、4枠が予定されています。本セッションでは、その締めくくりとして、世界各国で活躍中のパネラーを迎えて「国際パネルディスカッション: INORMS 2020 Hiroshima へ向けて」を行います。その内容として、「INORMS2018エジンバラ大会」においても課題となり、INORMS国際ワーキングのテーマでもある「Research Impact」の紹介を行い、さらにアジア地域で最初の開催となる「INORMS2020広島」において、初の試みとなる「広島宣言」の採択に向けてディスカッションを行います。この「広島宣言」に関しては、INORMS参加各国(欧米・オセアニア・アジア)の研究者・アドミニストレーション活動と連携・融合した上で、協働で決定する基本コンセプトなどについて議論をしなければなりません。なお、このパネルディスカッションのモデレーターは、「INORMS2020広島」のプログラム委員長である奈良先端大・三宅雅人准教授が担当し、同プログラム委員の東大・ハリスケイトURAと共に議論をリードしていきます。
